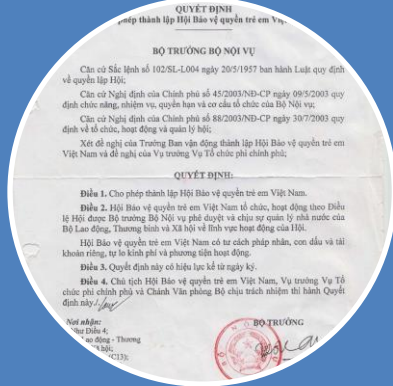

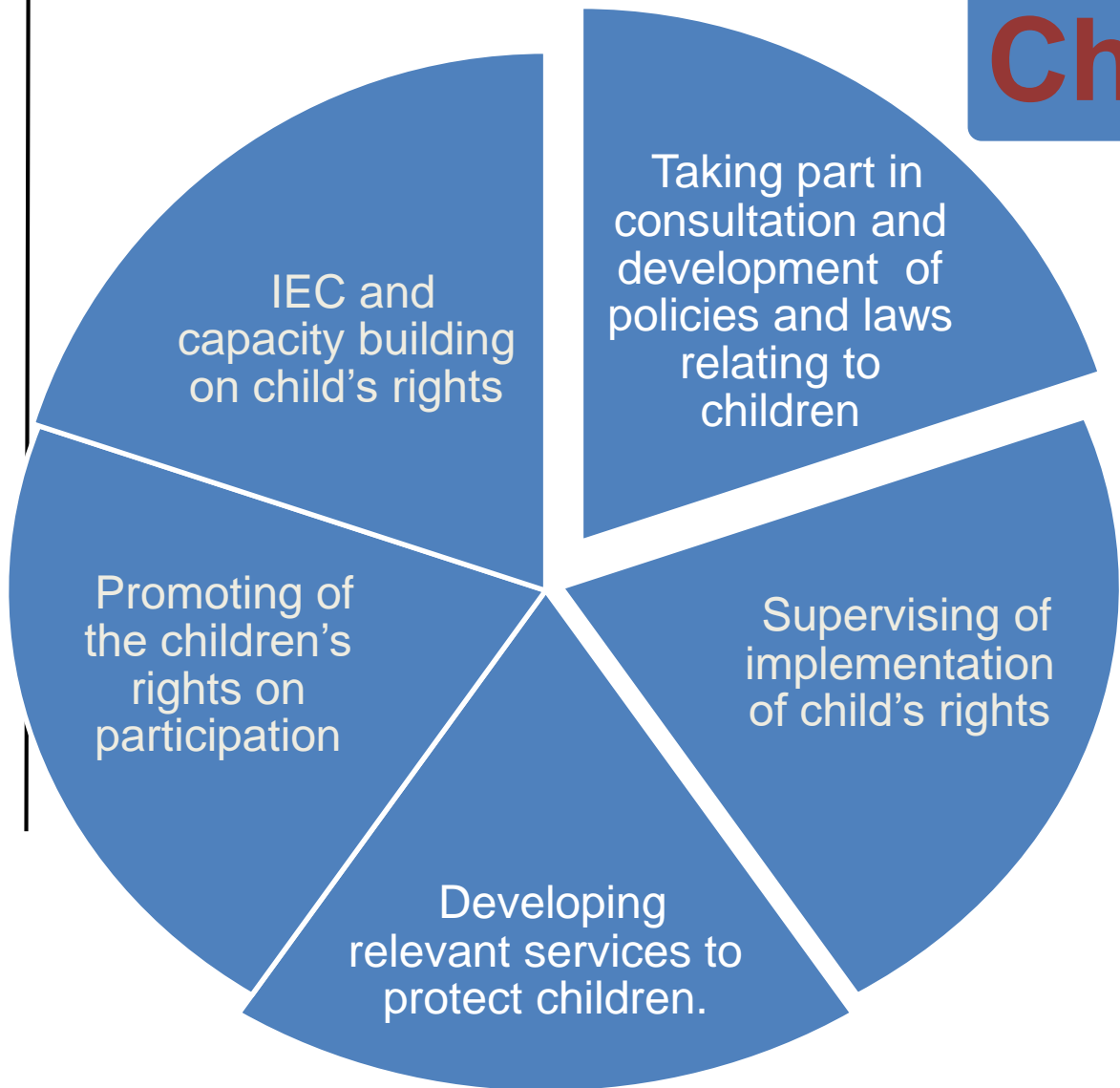

Targeted groups - priority: Children especially girls in and at risk of difficult circumstances such as abandoned children, orphaned children, children with disability, children living with HIV/AIDS; abused and exploited children, transferred children, immigrated children, street children, children living in mountainous and remote areas...

Program 2: Taking part in building policies and laws of children



1. Updating, collecting the information of draft legal regulations, policies.

2. Development of a Framework on Child Rights Impact Assessment (CRIA)

3. Collecting information from social organizations and children to convey to relevant agencies and follow the results.

4. Giving suggestion and taking part in drafting policies, socio economic plans, laws relate to children at national, provincial and district levels

5. Conducting consultation, surveys, research on implementation of relevant policies and programs on children

6. Organizing periodical forums for the social organizations about the children's rights implementation.



Program 3: Supervising of implementation of child's rights



Performing missions as member of Vietnam Fatherland Front Central Committee member and National Committee for Children, on the basis of summarizing opinions of social organizations and children



Engaging in relevant State delegations to supervise the implementation of children's rights



Speaking out opinions on violations of child's rights



Dealing with complaints about violations of child's rights, giving recommendations and orientation on supporting to vulnerable children and their family, providing related legal and psychology support...

Program 4: IEC and capacity building on child's right



1. Developing child – friendly communication materials on child's rights (manual documents, video...)

2. Organizing talkshows with specialist on child's rights (online and offline) in residential district, industrial zone.

3. Conducting communication events at schools such as hypothesis trial models, drama stages...

4. Providing awards for organizations, individuals, and children who have contributions in implementing and protecting child's rights





Program 5: Building evidence base, developing models/services on child care, protection of child's rights...



1. Preventing drop out children, providing scholarship to schools

2. Preventing and protecting children from violations (child labour, child abused...)

3. Parenting education on relevant skills, including positive discipline on children education

4. Child care interventions (nutrition support, reproductive health, mental health...)

5. Community development

Program 6: Promoting children's participation



1. Training children about their rights

2. Supporting children to participate in national and regional children's forums

5. Organizing competitions for children

3. Consulting children in the community.

4. Supporting children to give their proposals in child's rights protection in the community.

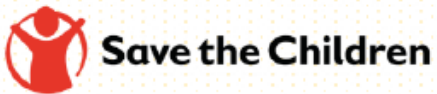
